Once exercised, such restricted stock cannot be sold without the approval of the board of directors of the Issuer.
- 2. Does not give effect to 2.88-for-1 stock split, which the Issuer expects to effect in connection with the closing of its initial public offering on October 22, 2021. After giving effect to such split, the number of securities underlying the option will be 122,688 at an exercise price of \$9.33.
